





In pursuance to Lr. No.11627/WR dtd.25.04.2024 of the Director R& R –cum- Additional Secretary to Govt. in DOWR, Odisha, Bhubaneswar, Sealed quotations are invited from interested reputed Travel Agencies / Tour Operators or private individuals for providing one no. of Non AC/ AC Diesel driven vehicles having seating capacity not more than ten & not less than four including driver, which shall conform to the Terms and conditions (Annexure-II) for official use in Office of the Zone Officer, Baghuabol, Talcher on monthly rent basis w.e.f 01.06.2024 to 31.05.2025.

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Spl.L.A.R.&R.O.,R.I.P.,Sukinda, Jajpur and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants).
6. The vehicle must achieve a fuel efficiency of 10 Kms. per liter.
