Sub: Guidelines for Engagement of Guest Faculty in Govt. Vocational Higher Secondary Schools during the Academic Session 2024-25.

Sir /Madam,

In enclosing here with the guidelines of Government in School & Mass Education Department communicated vide letter No. 14801/SME dated 01.07.2024 for engagement of Guest Faculty in Govt. Vocational Higher Secondary Schools during the academic session 2024-25, I am to request you to complete the selection process of Guest Faculty in the following manner:-

1. The engagement of trade wise guest faculty will be made as per approved Govt. Guidelines through open advertisement. The preference in selection will be given as stipulated in the guidelines.
2. The process for engagement of guest faculties for 2024-25 as per the new guidelines may be initiated as per the given schedule:

Sl. No.	Activity	Date line
1	Publication of Advertisement	By 16.07.2024
2	Certificate Verification & publication of selection list	By 24.07.2024
3	Last date for Issuance of engagement Order	30.07.2024

3. Engagement of guest faculties should be made in Priority basis in the GVHSS having student's strength in 12th class. They will take both XI & XII classes.
4. If there are no 2nd year students at present, but students get admitted to class XI, guest faculties may be engaged as per guideline.
5. The selection of all guest faculties must be completed by **30th July 2024**.
6. The guest faculties so selected may take classes of both classes of XI & XII of the trade from 1st August 2024 till closure of Schools for next summer vacation 2024-25 or posting of Junior Lecturer in the School whichever is earlier.
7. The qualification of new vocational trade subject will be provided soon.
8. In case of joining of any Junior Lecture against any trade, the engagement of guest faculties may be withdrawn as per undertaking.
