


Sealed tenders are invited from registered agency/firm for supply of Office Furniture & Fixture at OAV Subarnapali, Pallahara, Angul as term & condition of the Tender

Eligibility Criteria:

01. Firms must be Registration under MSME Odisha
02. Firms having valid PAN/TAN certificate
03. Firms having under GST Registered
04. Firms Must be ISO 9001-2015 & ISO 14001-2015 certificate
05. Firms must be average 02 year turnover is Rs.01.50 cores

Terms & Conditions :

1. Bid document can be downloaded from the District Website <https://angul.odisha.gov.in/>
2. The bidders are required to submit the non-refundable tender document fee of Rs. 5,000/- (Rupees Five thousand) only in shape of a Demand Draft in favour of the "District Education Officer, Angul" and payable at Angul from any nationalized/ scheduled bank along with the Tender Paper. Proposals received without or with inadequate fees shall be rejected.
3. Bidders shall submit, along with their Technical Bids, EMD of Rs.30,000/- (Rupee Thirty thousand) only in the shape of Demand Draft in favour of the "District Education Officer, Angul" from any nationalized / scheduled bank. EMD of all unsuccessful bidders would be refunded within 15 days of the bidder being notified as unsuccessful. The EMD, for the amount mentioned above, of successful bidder would be kept as part of Performance Guarantee till acceptance of final deliverable along with the additional performance security to be deposited by successful bidder
4. The response to Technical Bid and Financial Bid should be covered in separate sealed envelopes super-scribing "Technical Bid" and "Financial Bid" respectively. The two envelopes containing copies of Technical Bid and Financial Bid shall be put in another single sealed envelope clearly marked as "Supply and installation of furniture to OAV Subarnapali under Pallahara Block of Angul District.
5. If any bidder is submitting any conditional bid, then it will not considered & rejected out rightly.
6. **The bid along with documents may be submitted to the District Education Officer, Amalapada, Angul, Odisha, PIN – 759122. Last Date & Time of Submission: Dt.23.08.2024 up to 11.00 A.M. (through registered / speed post only). No other mode of submission is allowed.**



7. Bids received after the due date and the specified time (including the extended period, if any) for any reason whatsoever, shall not be entertained and shall be returned unopened.
8. DEO, Angul reserves the right to modify and amend any of the above-stipulated condition/criteria depending upon project priorities vis-à-vis urgent commitments.
9. The bid documents submitted will be opened on scheduled date and time by the tender committee, in the presence of the Bidders or their authorized representatives, who may be present at the time of opening. The representatives of the bidders are advised to carry the identity card or a letter of authority from the tendering firms to identify their *bona fides* for attending the opening of the proposal.
10. Affidavit by the authorized signatory of the bidder that the bidder has not been blacklisted by any Central / State Government (Central/State Government and Public Sector) or under a declaration of ineligibility for corrupt or fraudulent practices must be submitted on original letter head of the bidder with signature and stamp.
11. Average Annual Turnover during last two financial years (as per the last Audited Balance Sheets) minimum Rs. 1,50,00,000/- (Rupees two core Fifty lakhs) only.
12. The bidders to submit certified copy of the Audited Balance Sheet and Profit & Loss Account for last three F.Y. 2021 – 22, 2022 - 23 and 2023 - 24)
13. The Bidders must have a own office within the Angul District.
14. The cost of the Item as well as total quoted cost must be included all taxes , levies and transport cost to the school point. No extra cost on & over the quoted price will be considered or accepted.
15. TDS will be deducted from the billing amount as per IT norm.


