**TERMS AND CONDITIONS FOR SUPPLY OF GAZELLE HB VARIANT TEST MULTI PACK UNDER CDM&PHO, ANGUL FOR A PERIOD OF ONE YEAR.**

1. The bidders may download the tender documents from the District Web Site: [www.angul.odisha.gov.in](http://www.angul.odisha.gov.in). The bidders are required to submit Tender document fee of **Rs.3,000/- (Rupees Three Thousand Only)** (non-refundable) in shape of Demand Draft in favor of **ZSS, Non-NRHM, Angul**.
2. The bidders are required to submit Earnest Money Deposit of Rs 20,000/- (Rupees Twenty Thousand Only) (Refundable) in shape of Demand Draft in favor of **ZSS, Non-NRHM, Angul**. EMD money will be refunded to the unsuccessful bidders. If the bidder qualified in technical bid the EMD will be kept as security money and return after One Year and if the bidder is not qualified in technical bid the EMD will be refunded at the same day without opening the financial bid of the bidder.
3. The tender paper will be rejected if the bidder changes any clause or Annexure of the bid documents downloaded from the website.
4. Sealed tenders will be received by date 29.08.2024 up to **05:00 PM** by the CDM&PHO, Angul in the office of the CDM&PHO, Angul for the purchase of **Gazelle HB Variant Test Multi Pack**. Any tender paper received after the due date and time will be rejected and returned back the unopened bid to the sender. The tender paper will be received through Speed Post/ Regd. Post/Courier Only.
5. The CDM&PHO shall have no responsibility for any delay / omission on part of the bidder and reserves the right to reject any or all the tenders without assigning any reason thereof.
6. The bidder(s) are to submit their tenders in separate sealed covered envelops for Technical Bid and Price Bid by superscripting **Cover 'A' (Technical Bid)** and **Cover 'B' (Price Bid)** & both the sealed covers should be put into a third outer cover which should be superscripted as "**Tender for Supply of Gazelle HB Variant Test Multi Pack for the year 2024-25**" and **Tender Reference No. / 1552, dt-06.08.24**.
7. The sealed tenders will be opened by the CDM&PHO, Angul in the office chamber of CDM&PHO, Angul on Dated 30.08.2024 at **11.00 AM**. The bidders or their duly authorized representatives are allowed to be present during the opening of the tender, if they so like.
8. The rate quoted by the bidder should be inclusive of all taxes (GST/Transportation/Freight/Insurance/ any other cost etc.).
9. Conditional tenders are liable to be rejected. All Disputes are subjected to Hon'ble Court of Angul, Odisha.
10. Bidders should submit the valid drug license/challan copy of renewal of Drug license photocopy (self attested) from the Drug Controller.
11. If the successful bidder/ bidders fail to supply within the stipulated period i.e. 45 days (forty five days) from date of receipt of final proof from CDM&PHO, Angul, liquidated damage @0.5% the tender value per week of delay shall be deducted from the final payment. The maximum delay time acceptable is 8 weeks. Hence, the maximum liquidated damage shall be up to 4% of purchase order. If the bidder fails to supply within the maximum delay time his order stands cancelled automatically.
12. The Authority will not make any advance payment to the organization. The organization will have to carry out the entire job on its own and the amount will be paid only after satisfactory completion of the job and submission of bill in that regards.
13. The cost towards the testing of sample will be borne by the successful bidder 2% of purchase order.

14. The supply of items shall be made immediately according to volume after placing the supply order in the office of the CDM&PHO, Angul and supplier shall submit the bill for payment at the approved rate in respect to quantity of items supplied. The transportation of items is sole responsibility of the supplier and must deliver the item on door delivery basis.
15. In case of failure on the part of the approved supplier to supply of the above mentioned items as per supply order within stipulated period, the CDM&PHO, Angul shall be at liberty to purchase above mentioned items from other sources and the approved supplier shall be liable to pay the excess amount which this office have to incur being the different of actual amount of purchase minus the amount as per approved rates and difference aforesaid shall be recoverable and adjustable against the security deposit amount.
16. Under no circumstances shall the organization appoint any sub-contractor or sub-lease the contract. If it is found that the organization has violated these conditions, the contract will be terminated forthwith without any notice and security deposited by the organization shall be forfeited.
17. Rates quoted against this tender notice shall remain valid up to 12 months after the award of contract. No request for an increase in rates, if any, will be allowed or entertained during this period.
18. Receiving & Opening of Tender may be changed if required by the under Signed, it will be intimated.
19. Bidders should submit a photocopy of a valid GST Regd. Certificate & PAN Card.
