Zilla Parishad, Angul on behalf of Panchayati Raj & Drinking Water Department, Government of Odisha invites tenders with certain terms and conditions in prescribed formats from reputed & registered man power service providing agencies/ companies/ firms for engagement of 08 nos of Additional Computer Programmers (ACPs) (08 Blocks – 1 each) & 08 nos. of Data Entry Operators (DEOs) (08 Blocks-1 each) to be engaged under MGNREGS scheme for providing support in smooth implementation of MGNREGS scheme in Angul District.

The Selection of service provider agency will be of two bid systems i.e. Technical Bid & Financial Bid. The agency that qualifies the Technical Bid will be allowed to participate in the Financial Bid. Tender Documents along with all documents can be submitted by the interested bidders through **Speed Post/ Registered Post** only addressed to "**Chief Development Officer-cum-EO, Zilla Parishad, Angul- 759122, Odisha**". The bidder should submit their **Technical & Financial Bid** in two separate envelopes & both these envelopes are to be packed inside one sealed envelope indicating "**Technical Bid**" & "**Financial Bid**" on top of the respective envelopes. 3. Cost of Bid Document: ₹ 10,000/- (Rupees Ten Thousand) only in shape of DD in favour of Chief Development Officer-cum-EO, Zilla Parishad, Angul from any scheduled commercial bank payable at Angul.
4. Cost of EMD: ₹ 1,00,000/- (Rupees One Lakh only) in shape of any of the following can be submitted: -
 - i) Minimum 02 years Fixed Deposit (from any scheduled commercial bank) duly pledged in favour of "Chief Development Officer-cum-EO, Zilla Parishad, Angul".

- ii) **Minimum 02 years Term Deposit (from any scheduled commercial bank) duly pledged in favour of "Chief Development Officer-cum-EO, Zilla Parishad, Angul".**
- iii) **Postal Deposit/ National Savings Certificates with minimum lock in period of 02 years duly pledged in favour of "Chief Development Officer-cum-EO, Zilla Parishad, Angul".**
