Where as Sri Ghanashyam Sahoo and Debasish Thamba Transport Agent was entrusted to supply of rice and wheat under SNP to all ICDS Projects of Angul district vide District Social Welfare Office Letter No.2110/SW/ Dt.15.11.2016.


Where as it is viewed that you have not supplied the Rice and Wheat to the concerned ICDS Projects in time, as a result a short supply of 3398.25 quintals of rice valuing Rs.1.14 Crore has come to the notice of Audit as per Para No.2 & 4 of the C& AG (G& SS) Report No.5 of 2021 during the financial year 2016-2019. Due to this reason the children were deprived of the benefit of food under SNP.

The Transport agent had executed an agreement that if any misappropriation is discovered during inspection or otherwise, a penalty shall be levied accordingly an amount of Rs. 557433/- to Debasish Thamba & Rs. 2908015/- to Ghanashyam Sahoo is penalised which is equivalent to 10 times of the cost of misappropriated food grains and legal action has already been initiated.

As the Transport Agent has failed to keep his commitment, It has been decided to initiate penal action as per guidelines. Accordingly as per the provisions laid down in the agreement Sri Debasish Thamba and Sri Ghanashyam Sahoo are hereby penalised & blacklisted in the state of Odisha.


