The tender documents will be opened in the office chamber of Deputy Director Horticulture, Angul on the next day i.e. on 11.12.2024 at 11.00 AM in the presence of the tenderers or their authorized representatives. Terms & Conditions:

1. Eligibility Criteria:

- The bidder must be a recognized supplier with experience in the supply of agricultural / horticultural products. Copy of Govt. certificates, if any shall be submitted along with the tender document.
- The bidder must submit valid GST registration, PAN card, and other legal documents as applicable.
- The bidder must submit a copy of the previous supply orders or certificates from other government / private organizations as proof of experience.

2. Required Documents:

- Copy of the registration with any Govt. body recognizing as supplier of agricultural / horticultural products.
- Copy of the authorized dealership certificate.
- GST Registration Certificate
- PAN Card
- Firm/Agency Registration Certificate
- IT return copy for the assessment year 2023-24 & 2024-25 i.e. FY 2022-23 and 2023-24
- Average Annual Turnover should be at least Rs. 10.00 Lakh in last two year as on 31.10.2024.
- Copy of the Experience Certificate or Supply Order *for last 3 years*.
- EMD Cost 10,000/- in favour of the Deputy Director Horticulture, Angul (Refundable) in shape of demand draft from any scheduled bank payable at Angul.
- Bid Paper cost of Rs.2,000/-/- in favour of the Deputy Director Horticulture, Angul (Non - refundable) in shape of demand draft from any scheduled bank payable at Angul.

- Payment will be made as per the norms set by the office after successful delivery and inspection of the products.
- 60% release of payment after delivery of the seeds in good condition.
40% release of payment after germination of seeds.
- No advance payment request will be accepted.

5. Characteristic of quality seed potato:

- True to the type
- Tuber weight should not be less than 30 gram
- Uniformity in size and shape
- Free from bruises, cracks disease, sunscald and rot.
- Presence of 3 – 4 nos of prominent eyes per tuber.
- Disease tolerant
- Packed in new gunny bag with proper aeration facility
- Packaging size 50 kg

6. Delivery:


- The delivery of the supplies should be made in accordance with the work order specified, after the completion of the tender process and finalization of the bidder. Delayed deliveries will attract penalties as per the terms of the agreement (delivery of material should be within 15 days from issue of the purchase order). The cost includes loading, unloading and transportations and other incidental expenses to delivery points of respective Block HQ.

7. Rejection of Tender:


- The Deputy Director, Horticulture reserves the right to reject any or all tenders without assigning any reasons.
