OFFICE MEMORANDUM

Sub.: Floating of tender for hiring of vehicles for monitoring of implementation of different Health Programmes by the Programme Officers of DHH of Angul District under the administrative control of the CDM & PHO Angul

In pursuance to Govt. of Odisha, Health & FW Department File No.HFW-SCH-I-MISC-0065-2023-24509/H Dated.06.10.2023 which has been conquered by Finance Department File No.FIN-SOS3-MV-0005-2023; Govt. has pleased to provide hiring vehicles for adequate logistic support to CDM & PHO, SDMOs and Medical Officers of AD/JD rank posted at District level and given charge as programme Officers under different programmes and Schemes.

Sealed quotations/tenders are invited from interested reputed Travel Agencies / Tour Operators / Private individuals for providing **1(One)** of AC Petrol/Diesel driven vehicles having sitting capacity not more than 7(Seven) including driver, which shall conform to the Terms and conditions (Appendix-A) for official use in **DHH Angul** on monthly rent basis:

1. The Quotation completed in all respect should reach the undersigned on or before **08.01.2025 by 5:00 P.M.** and shall be opened on **09.01.2025 at 11:00 AM** in the office chamber of the CDM & PHO, Angul in presence of the bidders or their authorized representatives and designated authorities.
2. The application form of quotation/tender containing General Bid Information & Terms and conditions for Hiring of Vehicles etc. will be available with DMO (MS)-cum-Superintendent DHH Angul on payment of Tender Cost Rs.2,000/- (non refundable) & EMD of Rs.10,000/- (Refundable) from 19.12.2024 to 08.01.2025 or can be downloaded from www.angul.odisha.gov.in from Dt. 19.12.2024 to 08.01.2025. In case the application form is downloaded from website, the applicant shall furnish a Demand Draft for an amount Rs. 2,000/- (Rupees Two Thousand) in shape of Account Payee Bank Draft drawn in favour of the **Rogi Kalyan Samiti DHH Angul** payable at Angul only towards the cost of application along with the application.

Note-2: The mileage, as prescribed above, shall also be applicable for equivalent model of Government Vehicles.


Note-3: The expenditure will be debitible to the unit-943-MV-hiring charges of the respective establishment.


- The Tenderers/ Bidders have to submit separate tender documents cost and EMD for each proposal.



TERMS & CONDITIONS
PROVIDING OF DIFFERENT VEHICLES ON MONTHLY & DAILY RENT BASIS

- 1) The firm must be registered under CGST / SGST Act.
- 2) The tenderers are to deposit **Rs. 2000/-** towards cost of tender documents (Non Refundable) in shape of Bank Draft / Banker's Cheque favoring the **Rogi Kalyan Samiti DHH Angul**. The tender documents submitted without paper cost shall not be entertained at any stage.
- 3) The tenderers are to deposit **Rs. 10,000/-** as EMD in shape of Bank Draft / Banker's Cheque favoring the **Rogi Kalyan Samiti DHH Angul** along with the tender documents. The tender documents submitted without EMD shall not be entertained at any stage. The EMD deposited will be refunded (Refundable without interest) to the unsuccessful tenderers soon after completion / finalization of the tendering process.
- 4) The authorization letters if any to be enclosed in the tender with due attestation.
- 5) The quoted amount must be excluding GST, which will be made payment separately.
- 6) The contract of the successful bidder may be extendable, up-to two years subject to satisfactory performance review by the undersigned at the end of 1st year of contract.
- 7) No conditional tender will be accepted by the authority from the tenderers.
- 8) No advance payment will be made to the party after acceptance of tender or execution of order.
- 9) Original documents are to be produced for verification by the members of the committee.
- 10) If any information / document furnished by the tenderers with the tender papers as asked for are found to be misleading or incorrect at any stage their tenders will be rejected without assigning reasons thereof.
- 11) The tenders received beyond the scheduled date and time will not be entertained / considered at any cost.
- 12) The CDM & PHO Angul is not bound to accept the lowest rates and reserves the full right to accept in full or part or reject any or all the tenders without assigning any reason thereof.
- 13) In case of any legal dispute, it will be adjudicated within the jurisdiction of Angul court only.
- 14) All pages of the bids are to be signed & stamped by the tenderer.
- 15) Details of information are to be submitted following **Two Bids i. e. Technical Bid (Tenderer's Profile with all relevant documents including paper cost & EMD) & Financial Bid**. The technical bid and the financial bid should be sealed by the bidder in separate envelope duly super scribed and both these sealed envelope are to be put in a bigger envelope which should also be sealed and duly super scribed.
- 16) The Tenderers should furnish the particulars in the specific format attached (to be sealed on sealing wax) in a sealed envelope super scribed as "**Tender for Hiring of Vehicles on Monthly Basis for DHH Angul in reference to Advertisement No. 974 dtd. 19.12.2024**" on the top to the sealed cover within the date & time specified above by Registered / Speed Post / Courier Service. No Tender will be received by hand. The authority shall not be responsible for any postal delay.
- 17) The technical bid and the financial bid shall be opened on the scheduled date and time in the office of the Chief District Medical & Public Health Officer in presence of the tenderers or their any authorized representative.
- 18) The tenderers qualified in the technical bids shall be eligible for the financial bid.
- 19) Penalty @ Rs. 500/- per day on account of delay in providing services will be levied for non-compliance of assigned work without any reason thereof & the same will be deducted from the monthly bill of the successful bidder.
- 20) The firm / organization should not be blacklisted by any Government organization. If found later on, the action deemed to fit will be initiated against the firm as per the law.
- 21) **The tenderes should submit photo copy of the work orders / contract agreement at least 3 Nos. of different Government offices as documentary evidence for the last 3 Years.**
- 22) The annual transaction / turnover of the tenderers having not less than 12 Lakhs per annum can participate in the tender. Photo copy of the documentary evidence should be attached with the technical bid.
- 23) During the period of contract, the Hired vehicle shall have all necessary valid documents such as:- M.V. Registration Certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit, Up to date tax payment, Valid Driving

- License of the Diver and all Odisha permit for performing tour programmes in different districts across the state. The Office hiring the vehicle shall not be responsible for any damage / loss caused to hired vehicles or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The Agency concerned shall be responsible for all such litigation.
- 24) The hire charges to be paid for monthly basis is final but does not include cost of fuel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms.
 - 25) All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, Gear Box and differential coolant, Tyres and Tubes, Battery etc. will be borne by the bidder.
 - 26) It shall be the responsibility of the bidder to provide a well behaved and punctual driver and the salary of the driver shall be borne by the successful bidder.
 - 27) In case of breakdown for reason whatsoever the replacement of a vehicle of the same or better model shall be provided by the successful bidder.
 - 28) In case of the vehicle do not report regularly on time, the authority will be at liberty to reject the arrangement and may engage vehicle from other source.
 - 29) The vehicle shall report for duty for minimum of 25 days in a month.
 - 30) In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
 - 31) Monthly hire charges and reimbursements towards cost of fuel (as per actual) and lubricants (as per the norms of Government of Odisha) will be paid in every succeeding month as per as possible within fifteen days of the submission of bills (as per availability of Govt. allotment) by the respective establishment where the vehicle will be officially used by the service provider and no advance payment will be made.
 - 32) The vehicle shall not be more than three years of old from the initial registration and also in good running condition during the period of contract. The vehicle older than five years should be replaced by new vehicles by the agency.
 - 33) If the services are found to be unsatisfactory, the client shall give one month notice & terminate the agreement.
 - 34) In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
 - 35) If the bidder violates any of the terms of contract, Chief District Medical & Public Health Officer, Angul shall forfeit the entire amount of security deposit.
 - 36) After finalization of the tender, the successful bidder shall furnish information in Annexure-III as prescribed by the Government of Odisha.
 - 37) In case of no tenderer found suitable, the monthly hiring of vehicles will be as per the Finance Department circular .22924/F Dt.14.08.2023 and if any amended from time to time
 - 38) The price quoted by the tenderers exceeding the rate of monthly higher charges & offering below the mileage prescribed by the Government of Odisha shall not be taken into account.
 - 39) In case of exigencies / visit of State Guest / protocol duties, hiring of vehicles will be used from the empanelled agency of State Guest House / Home Department (Protocol) / OTDC.

 - 41) Proprietor / Partner / Director having experience in providing hiring vehicles to Govt. institutions will be given preference to submit only the booking receipt of vehicle for consideration of tender
 - 42) The Chief District Medical & Public Health Officer, Angul reserves the rights to terminate the contract at any time without notice if the successful bidder fails to provide vehicles within the specified time.
