Terms & Conditions

1. The vehicle must be in road-worthy condition and shall not be more than 02 years old from the date of initial registration and also must have valid Registration Certificate, Fitness Certificate, Insurance, valid contract carriage permit, proof of up-to-date tax payment etc. which are mandatory for plying of vehicle.
2. The vehicle will be engaged for 01 year.
3. The Driver of the vehicle must have a valid license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
4. The Driver should be well behaved, gentle, Sound health condition and obedient in nature.
5. A ceiling of ₹31,000/- (Rupees Thirty one Thousand only) per month as heir charges is permissible as per Govt. guideline issued by finance department Memorandum No. 22924/F. Dated 14.08.2023.
6. The monthly rate of hire charges not excluding ₹31,000/- per month of the vehicle should be quoted separately in the general bid information (excluding fuel and lubricants).
7. The vehicle must be diesel running only and achieve a fuel efficiency of at least 10Kms.per litre.
8. The details of make and year of manufacture of the vehicle, registration number, mileage (kilometers cover per liter) and name of the driver with Driving License number and period of validity should be specifically provided in the general bid information to be furnished with the quotation/tender.
9. The quotation complete in all respect should reach the undersigned on or before 17-12-2024 by 2.00 PM and shall be opened on the same day at 4.00 P.M in presence of the bidders or their authorized representatives.
10. The application form of quotation/tender containing general bid information along with the terms and conditions for hiring of vehicle will be available with the LAO(G), Angul.
11. The vehicle cannot be used for private purpose.

12. The vehicle will stand in the campus of Collectorate, Angul and without prior permission of the undersigned/ LAO(G), Angul the vehicle cannot go outside of the campus.
13. Prior to the disengagement of the vehicle from the firms/owners end, before one month notice to be given to the undersigned.
14. The undersigned reserves right to terminate the vehicle without assigning any reason and prior notice thereof.
