Quotation/ Tender Call Notice for Hiring of Vehicle

Sealed quotations/ tenders are invited from interested reputed Travel Agencies/ Tour Operators or private individuals for providing **01 (One)** AC Diesel driven vehicle (Preferably TUV/SUMO Gold/BOLERO NEO) having sitting capacity not more than 8 including driver, which shall confirm to the Terms and Conditions (**Annexure-I**) for official use in **Office of Land Acquisition Office, Collectorate, Angul** on monthly rent basis.


- 1) The service provider shall have a **valid OGST registration to participate in the tendering process.**
- 2) The vehicle must be in road worthy condition, shall not be more than 2 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Under Control Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 3) The vehicle will be engaged for 01 year.
- 4) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 5) The Driver should be well behaved, gentle, sound health condition and obedient in nature.
- 6) A sum of **Rs. 5,000/-** shall be deposited by the intending bidders in shape of **Bank Draft** in favour of the **LAO(G), Angul** and submitted along with the tender as security deposit. After completion of tender process, the draft/amount will be refunded to unsuccessful bidders.
- 7) The monthly rate of hire charges be quoted separately in the general bid information (excluding fuel).
- 8) The Vehicle must achieve a fuel efficiency of minimum **10 Kms per litre** with maximum hiring charges of **Rs 31,000/- (Excluding Taxes i.e CGST@9% and SGST@9%)** per month is permissible as per Govt. guidelines issued by Finance Deptt. Memo. No.22924/F.14.08.2023.
- 9) The details of the model and year of manufacture of the vehicle, registration No., mileage (Kms covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/ Tender (**Annexure-II**).
- 10) The application form of quotation/ tender containing General Bid Information & Term and conditions for Hiring of Vehicles etc. will be made available in the office of the LAO(G), Angul on payment of Rs.100/- from the date of notification in the District Website www.angul.odisha.gov.in. In case the application form is downloaded from District website, the applicant shall furnish a Demand Draft of Rs.100/- (Rupees one hundred) only towards the cost of application along with the application.
- 11) The Tender/Quotation completed in all respect should reach the undersigned on or before **20.01.2025 by 5 P.M starting from the date of notification** by registered post/Speed post/dropping in Tender Box located in the Office campus of Collectorate, Angul only and same shall be opened on **dt.21.01.2025 at 3.30 P.M** in presence of the bidders or their authorized representatives.
- 12) Future corrigendum or other communication regarding this tender will be available only on the District Website www.angul.odisha.gov.in and will not be published in print media.

- 13) The tender received beyond the scheduled date and time shall not be taken into consideration. The authority reserves the right to reject/cancel any or all tenders without assigning any reason thereof and shall bear no liability what so ever consequent upon such decision.





TERMS & CONDITIONS FOR HIRING OF VEHICLES

1. The hired vehicle, during period of contract, shall have all necessary valid MV documents such as, valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L., of the Driver available all the times.
2. The Office of the Land Acquisition Officer(G), Angul hiring the vehicle shall not be held responsible for any damage/ loss caused to the hire vehicle or loss of life, injury made to any person or damages to any property on account of use of hired vehicle in any manner whatsoever. The owner shall be held responsible for all such litigation.
3. The hiring charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, tyres & Tubes, Battery etc. will be borne by the bidder.
4. It shall be the responsibility of bidder to provide a good Driver and the salary of the Driver shall be borne by the Owner.
5. In case of break down for reasons whatsoever the replacement of a Vehicle of the same or better model shall be provided by the Owner of the vehicle/ bidder.
6. In case of the Vehicle do not report regularly the authority will be at liberty to reject the agreement and may engage vehicle from other source.
7. The vehicle shall be engaged in duty throughout the month even on holidays, if required.
8. In case of emergency, the driver will have to report on duty as per the requirement of the hirer. No extra payment shall be demanded.
9. Monthly hire charges of the selected bidder will be paid in every succeeding month, as per as possible after submission of bill by the service providers and no advance payment will be made.
10. The vehicle shall not be more than 2 years old from the initial registration and also in good running condition during the period of contract.
11. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
12. In case the Service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
13. If the bidder violates any of the above terms and conditions of contract, office shall forfeit the entire amount of security deposit and the contract will be cancelled.
14. The Vehicle cannot be used for any private/commercial purpose beyond office hours or during holidays.
15. The Vehicle will stand in the campus of Collectorate, Angul and without prior permission of the undersigned/LAO(G), Angul the vehicle cannot go outside of the campus.
