Expression of Interest (EOI) is invited from the intending firms/suppliers having GSTIN registered for the state of Odisha for organizing Krushi Ratha Programme in Kharif & Rabi 2024-25 under CDAO, Angul which will depict the area specified content & critical messages vetted by Agriculture & Farmers' Empowerment by way of folk dance/drama/pala that could able to create awareness among the farmers with following modalities.

The Ratha will move in all the GPS/ important places for 05 days in each block and should be installed with a loud speaker accompanied by a group of folk dancers/drama artists to spread the message on different agriculture programme and taken by Agril. department at various place by way of Drama/Dance/pala. The RATHA will display important agricultural technology, disseminate important schematic programmes & other intervention implements in the District through folk dance/drama/pala. **The (EOI) should reach the undersigned by 27.2.25 up to 12 Noon The quotations shall be opened on 27.2.2025 at 3P.M** in presence of the applicant or their authorized representative & the committee members in the Office chamber of CDAO, Angul. The authority reserves the right to reject any or all quotations without assigning any reason thereof. The Eoi received in complete or after the scheduled date and time shall be summarily rejected. The sealed envelope containing the application should be superscribed "Eoi for Organising Krushi Ratha Programme-under the scheme IEC-State Plan. 2024-25" Rate (including GST) should be quoted for Krushi Ratha like:

1. Decoration of the Vehicle as per design given by the JDA(Information) (Vehicle with sound system).
2. Hiring Charges of the Vehicle for 5 days
3. Hiring Charges of the Artists for 5 days
4. Refreshment of the Artists, vehicle staff and departmental staff
5. Miscellaneous Expenditure
6. Total Expenditure per block.

Mandatory Criteria of a Agency/Firm:


7. The agency must have valid PAN number and GST registration with up to date income tax and GST clearance certificate.
8. The agency have not be in black listed.
9. Preference would be given to the agency who have past experience for similar assignments in Agriculture & Farmers Empowerment Department.
10. The vehicle must be in road worthy condition and shall not be more than 3 years old from the date of initial registration with valid RC, Insurance certificate, Fitness certificate, etc. and other valid document which are mandatory for plying of vehicle.
11. Driver of vehicle must have valid driving license for driving.
12. The vehicle should covered each GP headquarter of the District mandatorily.
13. The distance covered by the Krushi Ratha will be maintained in a log book & certified by the concerned BAO. Payment will be released by concerned BAOs of Blocks.




