The office of the District Social Security Officer (DSSO), Angul, invites Expressions of Interest (EOI) from eligible Non-Governmental Organizations (NGOs) for managing the Red Cross Special School for Deaf & Dumb and Blind (Classes 1 to 5) in Angul district. Interested NGOs are requested to submit self-attested copies of the following authenticated documents:

- Certificate of registration under the Societies Registration Act, 1860, or Indian Trusts Act, 1882, or Section 25 of the Companies Act, 1956.
- Certificate of registration under the Rights of Persons with Disabilities Act, 2016.
- Proof of currently operating a special school for the Deaf & Dumb and Blind.
- An undertaking confirming the NGO has not been blacklisted by any Central or State Government agency.
- Any additional documents as per the Guidelines for Establishment, Recognition, and Grant-in-Aid to Institutes Imparting Education to Children with Disabilities.

Applications must be submitted in plain paper to the office of the District Social Security Officer (DSSO), Angul, during office hours on working days, no later than 29th March 2025, 1:00 PM. Late or incomplete applications will not be accepted or considered.

Upon selection, the chosen NGO must commence operations of both special schools within 10 days and apply for Grant-in-Aid (GIA). For clarifications, contact DSSO Office, Angul.
