Quotation/ Tender Call Notice for Hiring of Vehicle


Sealed quotations/ tenders are invited from interested reputed Travel Agencies/ Tour Operators or private individuals for providing **01 (One)** Non-AC/ AC Diesel driven vehicle having sitting capacity not more than 8 including driver, which shall confirm to the Terms and Conditions **(Annexure-I)** for official use in **Panchayat Samiti Office, Pallahara** on monthly basis.

- 1) The service provider shall have a valid OGST registration to participate in the tendering.
- 2) The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Under Control Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 3) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 4) The Driver should be well behaved, gentle and obedient in nature.
- 5) A sum of **Rs. 5,000/-** shall be deposited by the intending bidders in shape of **Bank Draft** in favour of the **Block Development Officer, Pallahara** and submitted along with the tender as security deposit. After completion of tender process, the draft/amount will be refunded to unsuccessful bidders.
- 6) The monthly rate of hire charges is quoted separately in the general bid information (excluding fuel and lubricants).
- 7) The Vehicle must achieve a fuel efficiency of minimum **10 Kms per liter** with maximum **hiring charges of Rs 31,000/-** per month
- 8) The details of the model and year of manufacture of the vehicle, registration no., mileage (Kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/ Tender **(Annexure-II)**.
- 9) The application form of quotation/ tender containing General Bid Information & Term and conditions for Hiring of Vehicles etc. will be available in the office of the **Block Development Officer, Pallahara** on payment of Rs.100/- from **01.05.2025 to 15.09.2025** or can be downloaded from the District Website www.angul.odisha.gov.in from **01.05.2025 to 15.05.2025**. In case the application form is downloaded from Govt. website, the application form is downloaded from District website, the applicant shall furnish a Demand Draft for an amount of Rs.100/-(Rupees one hundred) only towards the cost of application along with the application.
- 10) The Tender/Quotation completed in all respect should reach the undersigned on or before **15.05.2025** by **1.00 P.M.** by registered post/ Speed post/By hand only and same shall be opened on **16.05.2025** at **11.30 A.M.** in presence of the bidders or their authorized representatives.
- 11) Future corrigendum or other communication regarding this tender will be available only on the District Website www.angul.odisha.gov.in and will not be published in print media.
- 12) The tender received beyond the scheduled date and time shall not be taken into consideration. The authority reserves the right to reject/cancel any or all tenders without assigning any reason thereof and shall bear no liability whatsoever consequent upon such a decision.


