Notice Inviting Tender

"Inviting application for grant of Quarry Leases"

In exercise of the power conferred by section 15 of Mines and Mineral (Development & Regulation) Act, 1957 and in accordance with the Odisha Mineral Concession Rules, 2016 as amended from time to time thereunder, the Government of Odisha has identified 01 Nos. quarry lease for electronic auction and hereby invites tender for the purpose of grant of Quarry Lease.

Accordingly, technical bids for grant of quarry lease are invited in the format of 'Form-M' both in digital and physical format from eligible bidders.

Eligible condition, date and time for participating in electronic auction are provided in Tender Document. Detailed Tender Document along with timeline, notification, updates and other details for the e-auction process for the quarries are available in electronic form only and can be downloaded from the website <https://www.mstcecommerce.com>.

Interested and eligible bidders can register themselves on the above website. On successful registration, eligible bidders will obtain login ID and password necessary for participation in the e-auction process. The intending bidders should submit necessary details and relevant mandatory documents in Form- M, by using valid login User ID and password. The bidders should refer to the "Bidders' Manual" for successful submission of 'Form-M' for participating in the tenders, which is available in the e- Auction portal. The period given to the bidder for submission of e-tenders for Technical Evaluation, is counted from the date on which the notice inviting tender (e-NIT) including e-tender is actually published in newspaper(s) and the website of the Directorate of Minor Minerals.
