As per the Finance Department O. M No.15836/F Dt-27-05-2025, PR Dept. Letter No.4516/PR,Dt-13-03-2015 ,DRDA, Angul Latter No.994,Dt-27-03-2015 and resolution of Block Tender Committee dated-30-05-2025 Sealed Quotations/Tenders are invited 2nd time from interested reputed travel agencies or private individuals for providing 01 (One) number of Non-AC/AC Diesel driven vehicle i.e **Bolero Neo(N-10)** having sitting capacity not more than seven including driver, Which shall confirm to the Terms and condition (Annexure-A) for supervision of **Rural Housing Scheme** in the **Panchayat Samiti Office, Kishorenagar** on monthly rent basis:

- 1) The service provider shall have a valid OGST registration to participate in the tendering.
- 2) The vehicle must be in road worthy condition, shall not be more than 3years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Pollution Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. Which are mandatory for plying of vehicle.
- 3) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 4) The Diver should be well behaved, gentle and obedient in nature.
- 5) A.sum of Rs. 10000/- (Rupees Ten Thousand) shall be deposited by the intending bidders in shape of account payee Bank Draft drawn in favour of the Block Development Officer, Kishorenagar and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 6) The monthly rate of hire charge, excluding GST be quoted separately, excluding fuel.
- 7) The vehicle must achieve a fuel efficiency of 10(Ten) Kms. Per litre.
- 8) The details of the make and year of manufacture of the vehicle, registration no. , mileage(Kms. Covered per liter) ,name of the Diver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation / Tender (Annexure-B).
- 9) The Quotation completed in all respect should reach the undersigned on or before **17-06-2025 by 1.00 P.M** which is to be dropped in the **Drop Box** in the office of undersigned / send by **Registered post** and shall be opened on the same day at **03.00 PM** in presence of the bidders or their authorized representatives in office chamber of undersigned. The quotations received after due time shall be automatically rejected.
- 10) The application form of quotation / tender containing General bid information and terms and condition for Hiring of Vehicle etc. will be available with the Block

Development Officer, Kishorenagar on payment of Rs.1000 /- in shape of cash / Bank Draft from 03-06-2025 to 16-06-2025 on working days or can be downloaded from Dist. Website i.e www.angul.odisha.gov.in from **03-06-2025 to 16-06-2025**. In case the application is downloaded from District website, the applicant shall furnish a demand draft for an amount of Rs.1000/-(Rupees One thousand) only towards the cost of application along with the application:



TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis:-

- 1) The hired vehicles, during period of contract, shall have all necessary valid MV documents such as :- Valid Registration Certificate, Insurance Certificate, Fitness Certificate , Pollution Certificate, valid contract Carriage Permit, Proof of up to date tax payment etc. and Driving License of the driver available all the times.
- 2) The Department / Officer hiring the vehicle shall not be responsible for any damage / loss caused to hired vehicles or losses of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall be responsible for all such litigation.
- 3) The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption as per existing Govt. Norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box, & differential coolant, Tyres and Tubes, Battery etc. will be borne by the bidder.
- 4) It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the service provider.
- 5) In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the service provider.
- 6) In case of the vehicle do not report regularly, the authority will be at liberty to terminate the agreement without prior notice.
- 7) The vehicle shall report for duty for minimum 30 days in a month.
- 8) In case of emergency, the driver will have to report for duty as per the requirement. No extra payment shall be made.
- 9) Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as far as possible within fifteen days from the date of submission of bills by the service provider and no advance payment will be made.

- 10) The vehicle shall not be more than 03 years old from the initial registration and also in good running condition during the period of contract.
- 11) If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
- 12) In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month advance notice before such withdrawal of service and termination of agreement.
- 13) If the bidder violates any of the terms of contract, Govt. shall forfeit the entire amount of security deposit.
