SCOPE OF WORK AND GENERAL INSTRUCTIONS FOR BIDDERS

1. The District Project Management Unit, PM Poshan, Angul requires the services of reputed, well established and financially sound Manpower Service Providers to provide services of 1 no's of Programmer-cum-Accountant and 9 Data Entry Operators, who are to be engaged at Programmer-cum-Accountant at DPMU and 8 Deo's at 8 Block Education Offices for PM Poshan Scheme and one Data Entry Operator at District Project Management Unit, PM Poshan, Angul.
2. The contract for providing the aforesaid manpower services is likely to commence from the **date of signing of the agreement** and would continue till the **completion of one year**. The period of the contract may be further extended beyond **one year** provided the requirement of the **Block Education Offices / District Education Office/ District Project Management Unit, PM Poshan, Angul** for manpower persists at that time or may be curtailed/ terminated before **one year** owing to deficiency in service or substandard quality of manpower deployed by the selected Service Provider or because of change in the **Block Education Offices / District Education Office/ District Project Management Unit, PM Poshan, Angul** however, the authority reserves right to terminate this initial contract at any time after giving one week's notice to the selected Service Provider.
3. The **Block Education Offices / District Education Office/ District Project Management Unit, PM Poshan, Angul** has tentative requirement 1 No's of Programmer-cum- Accountant and 9 No's of Data Entry Operator for Block Education Offices and District Project Management Unit, PM Poshan, Angul for (PM Poshan Programme).
4. The provisional estimated cost of the contract is **Rs.21,00,000/-** (Rupees Twenty-one Lakh) only for a period of one year.
5. The interested Manpower Service Providers may submit the tender document complete in all respects with requisite documents by 05.07.2025 up to 04:00 PM at District Project Management Unit, PM Poshan, Angul. 6. The tenders are invited under **two bid system i.e. Technical Bid and Financial Bid**. The interested agencies are advised to submit two separate sealed envelopes super scribing "**Technical Bid for providing Services of 1 Programmer-cum- Accountant and 9 Data Entry Operator for Block Education Offices and District Project Management Unit, PM Poshan, Angul** " and "**Financial Bid for providing Services of 1 Programmer-**

cum- Accountant and 9 Data Entry Operators for Block Education Offices and District Project Management Unit, PM POSHAN, Angul". Both sealed envelopes should be kept in a third sealed envelope super scribing "Tender for providing Services of 1 no's of Programmer-cum- Accountant and 9 no's of Data Entry Operators for Block Education Offices and District Project Management Unit, PM Poshan, Angul.

7. **TENDER PAPER COST:** The Tender Paper cost of Rs. 5000/- (Rupees Five Thousand) only, non -refundable should be necessarily accompanied with the Technical Bid of the service provider in the form of Demand Draft / Pay Order drawn in favour of the **District Nodal Officer, PM Poshan, Angul** failing which the tender shall be rejected summarily.
8. **EMD:** The bidders are required to deposit Rs.1,00,000/- (Rupees One Lakh only) as EMD, which will be refunded to the unsuccessful bidders. In case of successful bidders, it will be **converted into security deposit**. This EMD money shall be in form of Demand Draft / Pay Order drawn in favour of the **District Nodal Officer, PM Poshan, Angul** failing which the tender shall be rejected summarily.
9. **PERFORMANCE SECURITY:** The successful tenderer/bidder/Service providing agency will have to deposit **Security Deposit / Performance Security** either in shape of **Demand Draft or Pay order drawn in favour of the District Nodal Officer, PM Poshan, Angul** from any of the scheduled bank for a value equivalent to **@5% of the total contract value** covering the period of contract.
10. **BLACKLISTING:** Declaration by bidder that: That, our company/Firm is not blacklisted in any manner whatsoever by any of the State/UT and/or central government in India/ any PSUs on any ground including but not limited to indulgence in corrupt practice, fraudulent practice, coercive practice, undesirable practice or restrictive practice in the last five years up to the date of submission of bid or the black listing shall not be in force till the date of submission of bid, if awarded, prior to the said five years. That, neither the Company/Firm nor any of its director/s nor partner/s have been convicted by any court of law nor any criminal case be pending against them before court of law. The company/Firm will have to submit a self declaration in the Company Letter Pad. (Provide information as per the prescribed format at the **(Prescribed Format)**).
11. The tendering Manpower Service providers are required to enclose photocopies of the following documents (duly attested by Group "A" Gazetted Officers of the State Governments/Central Government), along with the Technical Bid, **failing which their bids Shall be summarily/out rightly rejected and will not be considered any further:**

 - (b) Copy of PAN card;
 - (c) Copy of GST Registration Certificate;
 - (d) Copy of Labor registration Certificate;
 - (e) Copy of the IT return filed for the last three financial years (2021-22,2022-23,2023-24);

 - (h) Copy of the Service Tax registration certificate;
 - (i) Certified extracts of the Bank Account containing transactions during last three years. (2022-23,2023-24, 2024-25)
 - (j) Certified Average Turnover copy(Rs.50.00 Lakhs) for the last three financial years (2021-22,2022-23,2023-24);
 - (k) Affidavit regarding not black listed/bankrupted/non-involvement in criminal activities.

12. The conditional bids shall not be considered and will be outrightly rejected in very first instance. Bid documents without signature will be outrightly rejected.
13. The remuneration of the outsourcing employees may be increase/decrease as per Government order and statutory dues changed accordingly but the service charges is fixed as per agreement.
14. The number of the outsourcing employees may be increase/decrease on the basis of requirement during the period of agreement but the service charges is fixed as per agreement.
15. There are already 01 programmer-cum-accountant and 09 DEOs are engaged by Manpower service providing agency. So, the successful bidder may engage these DEOs basing on performance.
16. The monthly remuneration of the outsourcing employees will be reimbursed after submission of the Absentee Statement along with monthly GST Bill, remuneration transfer Bank Statement, EPF & ESI deposit challan by the selected Bidder.
17. All entries in the tender form should be legible and filled clearly. If the space for furnishing information is insufficient, a separate sheet duly signed by the authorized signatory may be attached. No overwriting or cutting is permitted in the Financial Bid Form. In such cases, the tender shall be summarily rejected. However, the cuttings, if any, in the Technical Bid Application must be initialed by the person authorized to sign the tender bids.
18. Amendments to BID terms, conditions and issue of Corrigendum/addendum:
- a. The Term and condition mentioned at Bid Documents is final. Any Clarification/suggestion/objection/etc of any party will not be considered by the TIA.
 - b. The TIA may be change /amend/modify/etc any term & conditions of the Bid documents, for any reason.
 - c. The amendment in shape of corrigendum/addendum will be notified on the websites <http://angul.odisha.gov.in> only.
 - d. In order to allow prospective Bidder/s reasonable time in which to take the amendment into account in preparing their bid, the TIA may, at its discretion, extend the deadline for the submission of bids.
19. The Technical bids shall be opened on the scheduled time, date and at the venue i.e **10.07.2025 in the Office Chamber of the Collector, Angul** in the presence of the representatives of the Manpower Service Providers, if any, who wish to be present on the spot at that time.
20. The Financial Bid of only those tenderers will be opened whose Technical bids are found in order. The Financial bids shall be opened at **10.07.2025 in the in the Office Chamber of the Collector, Angul** in the presence of the representatives of the Manpower Service Providers, if any, who wish to be present on the spot at that time.
21. Service Charges levied by the bidder must be calculated as per minimum Govt rate and financial calculation statement acceptable up to point two decimal places only.

22. The Bid documents of the unsatisfied bidder worked under this organization is not considered.

23. Resolution of Disputes:

- (a) Any dispute between the Tender Inviting Authority (TIA) and the successful bidder/s should be addressed to the other party only in writing in their respective letter heads signed only by the designated signatories as in contract agreement. Both the parties shall make every effort to resolve the same amicably by mutual consultations.
- (b) If both the parties fail to resolve their dispute or difference by such mutual consultation within twenty-one days of its occurrence, the same will be finalized at Angul Jurisdictions only.

23. Applicable Law and Jurisdiction of Courts:

- (a) The Contract shall be governed by and interpreted in accordance with the existing law of India in force.
- (b) All disputes relating to the contract is subject to the pecuniary jurisdiction of the Court at Angul, Odisha

TERMS & CONDITIONS

GENERAL

1. The Agreement shall commence from **the date of signing agreement** and shall continue till **one year** unless it is curtailed or terminated by the authority owing to deficiency of service, sub-standard quality of manpower deployed, breach of contract etc or change in requirements.
2. The Agreement shall automatically expire **after one year** unless extended further by the mutual consent of the Manpower Service Provider and the Authority.
3. The Agreement may be extended, on the same terms and conditions or with some additions /deletions / modifications, for a further specific period mutually agreed upon by the Manpower Service Provider and the Authority.
4. The Manpower Service Provider shall not be allowed to transfer, assign, pledge or subcontract its rights and liabilities under this Agreement to any other agency or organization by whatever name be called without the prior written consent of the Authority.
5. The Block Education Offices, at present, has tentative requirement of 1 Data Entry Operator at each Block on urgent basis (for PM PoshanScheme) and 01 Data Entry Operator for DPMU and 1 Programmer-cum- Accountant for DPMU PM Poshan, Angul. The requirement of the Block Education Offices and DPMU, PM Poshan, Angul may further increase or decrease marginally, during the period of initial contract also and the tenderer would have to provide additional manpower services, if required, on the same terms and conditions.
6. The Manpower Service Provider will be bound by the details furnished by it to the Authority while submitting the tender or at subsequent stage. In case, any of such documents furnished by it is found to be false at any stage, it would be deemed to be a breach of terms of Agreement making it liable for legal action besides termination of the Agreement.
7. The Authority reserves the right to terminate the Agreement during initial period also after giving 15 days notice to the Manpower Service Provider.
8. There are already 1 Programmer-cum- Accountant and 09 Data Entry Operators working in Block Education Offices & DPMU, PM Poshan, Angul. The selected Manpower Service Provider may engage these Data Entry Operators basing on their performance as required. The age parameter as mentioned above, i.e 40 years will not be applicable for these candidates working in such places.
9. The persons deployed shall be required to report for work at 10.00 a.m in Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned and may also required to work beyond 5.30 PM for which he/ she would not be paid any extra remuneration. In case, the person deployed remains absent on a

particular day or comes late / leaves early on three occasions, proportionate deduction from the remuneration for one day will be made.

10. The Manpower Service Provider shall nominate a coordinator who shall be responsible for immediate interaction with the District Project Management Unit, PM Poshan, Angul so that optimal services of the persons deployed could be availed without any disruption.

11. The entire financial liability in respect of manpower services deployed in the Block Education Offices / District Education Office / District Project Management PM Poshan, Angul / Office concerned shall be that of the Manpower Service Provider and the Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned will in no way be liable. It will be the responsibility of the Manpower Service Provider to pay to the person deployed a sum not less than the minimum rate quoted in the financial bid and adduce such evidence as may be required by the Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned.

12. For all intents and purposes, the Manpower Service Provider shall be the "Employer" within the meaning of different Rules & Acts in respect of manpower so deployed. The persons deployed by the Manpower Service Provider shall not have any claim whatsoever like employer and employee relationship against the Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned.

13. The payment of remuneration to the manpower has to be through bank account only. No cash payment shall be made to the firm.

14. The Manpower Service Provider shall be solely responsible for the redressal of grievances or resolution of disputes relating to persons deployed. The Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned in no way, be responsible for settlement of such issues whatsoever. In case the grievances of the deployed person are not attended to by the Manpower Service Provider the deployed person can place their grievance before a Joint Committee consisting of a representative of the Block Education Officer / District Education Officer / District Nodal Officer, PM Poshan, Angul and an Authorized representative of the Manpower Service Provider.

15. The Block Education Officer / District Education Officer / District Nodal Officer, PM Poshan, Angul shall not be responsible for any financial loss or any injury to any person deployed by the Manpower Service Provider in the course of their performing the functions/duties, or for payment towards any compensation.

16. The persons deployed by the Manpower Service Provider shall not claim nor shall be entitled to pay, perks and other facilities admissible to regular / confirmed employees during the currency or after expiry of the Agreement.

17. In case of termination of this Agreement on its expiry or otherwise, the persons deployed by the Manpower Service Provider shall not be entitled to and shall have no claim for any absorption in regular or other capacity.

18. The person deployed shall not claim any benefit or compensation or absorption or regularization of deployment with office under the provision of rules and Acts. Undertaking from the person deployed to this effect shall be required to be submitted by the Manpower Service Provider.

19. The Manpower Service Provider must be registered with the concerned Govt. Authorities, i.e. Labour Commissioner, Provident Fund Authorities, Employees State Insurance Corporation etc., and a copy of the registration should be submitted. The Manpower Service Provider shall comply with all the legal requirements for obtaining License under Contract Labour (Regulations and Abolition) Act, 1970 if any, at his own part and cost. *

20. The Manpower Service Provider shall provide a substitute well in advance if there occurs any probability of the person leaving the job due to his/her own personal reasons. The payment in respect of the overlapping period of the substitute shall be the responsibility of the Manpower Service Provider. The Manpower Service Provider shall be responsible for contributions towards Provident Fund and Employees State Insurance, wherever applicable.

21. The persons deployed by the Manpower Service Provider should have good police records and no criminal case should be pending against them.

22. The persons deployed should be polite, cordial and efficient while handling the assigned work and their actions should promote good will and enhance the image of the Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned. The Manpower Service Provider shall be responsible for any act of indiscipline on the part of the persons deployed.

23. The remuneration of the outsourcing employees may be increase/decrease as per Government order and statutory dues changed accordingly but the service charges is fixed as per agreement.

24. The number of the outsourcing employees may be increase/decrease on the basis of requirement during the period of agreement but the service charges is fixed as per agreement.

25. The monthly remuneration of the outsourcing employees will be reimbursed after submission of the Absentee Statement along with monthly GST Bill, EPF & ESI deposit challan by the selected Bidder.

LEGAL

26. The persons deployed shall, during the course of their work be privy to certain qualified documents and information which they are not supposed to divulge to third parties. In view of this, they shall be required to take oath of confidentiality and breach of this condition shall make the Manpower Service Provider as well as the person deployed liable for penal action under the applicable laws besides, action for breach of contract.

27. The Manpower Service Provider shall be responsible for compliance of all statutory provisions relating to minimum wages payable to different types of worker in respect of the persons deployed by it in the Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned. The Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned shall have no liability in this regard.

28. The Manpower Service Provider shall also be liable for depositing all taxes, levies, Cess etc. on account of service rendered by it to the Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned to the concerned tax collection authorities, from time to time, as per the rules and regulations in the matter. Attested Xerox copies of such documents shall be furnished to the Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned.

29. The Manpower Service Provider shall maintain all statutory registers under the Law and shall produce the same, on demand, to the authority of Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned or any other authority under Law.

30. The Tax deduction at Source (T.D.S.) shall be done as per the provisions of Income Tax Act/ Rules, as amended, from time to time and a certificate to this effect shall be provided by the Department or office concerned.

* Note: - Registration/License under the Contract Labour (Regulation and Abolition) Act, 1970 is applicable to Manpower Service Provider employing more than 20 workmen.

31. In case, the Manpower Service Provider fails to comply with any liability under appropriate law, and as a result thereof, the Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned is put to any loss / obligation, monetary or otherwise, the Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned will be entitled to get itself reimbursed out of the outstanding bills or the Performance Security Deposit of the Manpower Service Provider, to the extent of the loss or obligation in monetary terms.

32. The Agreement is liable to be terminated because of non-performance, deviation of terms and conditions of contract, non-payment of remuneration of employed persons and non-payment of statutory dues. The Block Education Offices / District Education Office / District Project Management Unit, PM Poshan, Angul / Office concerned will have no liability towards non-payment of remuneration to the persons employed by the Manpower Service Provider and the outstanding statutory dues of the service provider to statutory authorities. TERMS & CONDITIONS OF THE AGREEMENT

1. The Agreement shall commence from _____ and shall continue till _____ unless it is curtailed or terminated by the authority owing to deficiency of service, sub-standard quality of manpower deployed, breach of contract etc. or change in requirements.
2. The Agreement shall automatically expire on _____ unless extended further by the mutual consent of the Manpower Service Provider and the Authority.
3. The Agreement may be extended, on the same terms and conditions or with some additions / deletions / modifications, for a further specific period mutually agreed upon by the Manpower Service Provider and the Authority.
4. The Manpower Service Provider shall not be allowed to transfer, assign, pledge or subcontract its rights and liabilities under this Agreement to any other agency or organization by whatever name be called without the prior written consent of the Authority.
5. The Manpower Service Provider will be bound by the details furnished by it to the Authority while submitting the tender or at subsequent stage. In case, any of such documents furnished by it is found to be false at any stage, it would be deemed to be a breach of terms of Agreement making it liable for legal action besides termination of the Agreement.
6. The Authority reserves the right to terminate the Agreement during initial period also after giving 15 days notice to the Manpower Service Provider.
7. The persons employed shall be eligible for special leave of 12 days for one year. The leave will not be carried over to the next year & will lapse on the completion of each year of service. 




