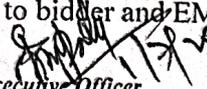

- 2 **Available and cost of tender paper:-** The EoI document/ DTCN alongwith specification, terms & conditions can be obtained from Angul municipality office during office hours from **dt.03.07.2025, 10.00 AM to dt.14.07.2025 upto 5.00 PM** except holidays on payment of tender paper cost **₹600.00** in shape of Cash/ Bank Draft/ Banker cheque drawn on any Nationalized Bank of in favour of **Executive Officer, Angul Municipality, Angul payable at Angul**. The paper cost will not refundable.
Request for Expression of Interest (EoI) documents through post will not be entertained.
- 3 **Earnest Money Deposit:-** The bidder must be accompanied by EMD/ bid security in original, amount **₹2,000.00** in shape of Cash/ DD/ Banker cheque/ National savings certificate/ Post office savings Bank account/ Post office Time Deposit/ Kissan Vikas Patra / Deposit Receipt of Schedule Bank drawn on any Nationalized Bank in favour of **Executive Officer, Angul municipality payable at Angul**.
EoI without payment of paper cost and EMD in original shall not be accepted in any case and will be rejected summarily.

Technical bid (cover-A), Price bid cover (B) and Third (cover C)
No bids will be received after scheduled date and time. The officer inviting the bid shall not be responsible for any postal delay and/ or non receipt due to any financial reasons.
- 5 **Opening of tender Paper:-** The Expression of Interest (EoI)/ bid documents will be opened in the presence of tender committee on **dt.16.07.2025 at 4.00 PM** in the chamber of Executive Officer, Angul municipality, Angul in the presence of the bidders or their authorized representatives who wish to attend. (Cover- "A")
(ii) Financial/ Price bid/ BoQ is to contain the price bid duly filled and signed by the bidder. (Cover- "B")
- 7 The Quotationer should quote single rate for each item according to required specification wherever mentioned. More than one rate for a particular item will be summarily rejected.



- 8 The bidder shall quote their rate including cost of fitting, fixing, erection, all materials, labour, T&P, transporting, loading & unloading etc as per description in BoQ/ specification.
- 9 The rate shall be quoted inclusive of all taxes and duties if any. GST will be mentioned separately.
- 10 Any correction or over writing in the offer should be attested by the quotationer.
- 11 The rate should be mentioned in both figures and words.
- 12 The rate will be valid for one calender year.
- 13 The bidder shall submit the quotation/ expression of interest schedule duly signed by him with seal.
- 14 The materials/ parts will be inspected by the Executive Officer/ Engineering person of Angul municipality/ or any competent authority authorised by municipality.
- 15 Any material/ parts found defective are to be replaced immediately free of cost.
- 16 The quotationer/ bidder shall not sublet, transfer or assign any part of the full work of this award without prior written permission from the Executive Office, Angul municipality.
- 17 Bids received will remain valid for a period of 90 days. The deadline date for submission of bids and validity of bids can also be extended, if agreed to by the bidder and the department.

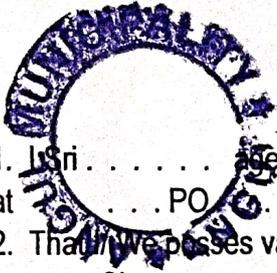

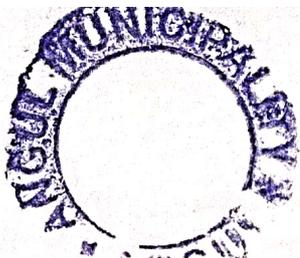
