3. The Bidders are required to submit a "Bid security declaration" along with their BID as per the Office Memorandum No. 5984 dt.27.04.2021 of Works Department, Government of Odisha in lieu of Bid Security in the format as mentioned under DTCN.
4. The bid documents will be available in the website: www.tendersodisha.gov.in from 10 AM of dt. 25.09.2025 to 5.00 PM of dt. 13.10.2025 for online bidding.
5. The bidder must possess compatible **Digital Signature Certificate (DSC)** of Class-II or Class-III.
6. Bids shall be received only "online" on or before dt. 13.10.2025 up to 5.00 PM.
7. Bids received online shall be opened at 11.00 A.M. on dt. 14.10.2025 in the office of the Divisional Forest Officer, Angul Division, Angul in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

8. The cost of bid documents should be paid online through e-procurement portal for the amount as specified under column no.5.
9. The successful bidder who has quoted less bid price / rate than the estimated cost put to tender shall have to furnish additional performance security (APS) in the shape of **Fixed Deposit Receipt / Bank Guarantee / Term Deposit Receipt** duly pledged in favour of Divisional Forest Angul Division Angul as per the rate mentioned in the table below within 7 days from date of intimation otherwise the bid shall be cancelled & security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.
10. The successful bidder undertaking the building work shall, at the time of the agreement, submit a security deposit equivalent to 3% of the contract value for C & D Class contractors and 5% of the contract value for B & A Class contractors. The security deposit shall remain valid for one year from the date of completion of the work.






