The Executive Engineer, Lift Irrigation Division, Angul, Odisha, invites tender on behalf of the Managing Director, OLIC Ltd., Bhubaneswar through e-procurement in shape of **percentage rate** bids in online mode only for the work **"Revival & Reinforcement** of following L.I. Projects under **Angul, Athamallik, Banarpal, Chhendipada, Kaniha, Kishorenagar, Pallahara & Talcher** blocks in Angul district on turn-key basis as detailed in the table below. The contractors must have valid Civil license of requisite class as per the Tender Call Notice and valid H.T. license and validity of both the licenses should be for a period at least 1 month from the date of the opening of the tender. Valid Joint Venture agreement should be made between Civil and Electrical Licences in case of separate Licences, where Civil Licence holder will be treated as prime contractor as because of the evaluation to be done under the capacity of PWD Contractor. The H.T. Electrical License should be issued by E.L.B.O. & Valid Civil Licence should be registered within the State, issued by PWD/ PHED/ RWSS/ Irrigation/ M.I. Deptt./ Rural works. The scanned copy of the joint venture agreement should be uploaded along with the bid, any deviations found will be summarily rejected. The bids should be submitted online on the website: www.tendersodisha.gov.in.



1. The Bids will be received in online mode only through e-tender portal and the documents will be available in the Govt. of Odisha e-tender portal i.e. tendersorissa.gov.in from **03.09.2025 to 11.09.2025** up to **17.00 hours**. The same will be opened on **12.09.2025** at **11.00 hour** onwards.
2. The detail projects list and DTCN is available on Notice Board & website: www.tendersorissa.gov.in/ www.angul.odisha.gov.in.
3. The Bidder will have to deposit as per NIT for each BID towards the cost of the tender paper including 18% GST and the EMD against each Package in Online mode through e-Portal.
4. For less quoting, the differential amount must be deposited as Additional Performance Security (APS) after opening of the tender as per OPWD codal rules.

The Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such an event only the successful bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e., the estimated cost put to tender minus the quoted amount as additional performance Security (APS) in shape TDR/NSC/ Kishan Vikash Patra & Postal Office Saving Certificate issued by any nationalized/ Scheduled Bank/Post Office located in India **pledged in favour of the Executive Engineer, L.I Division, Angul** within 7 (seven) days of letter of intent, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.

As per the Govt. of Odisha Works Deptt. Office Memorandum No 4559 W/dt.05.04.2021. The successful bidder shall provide the APS as follows:

- i) Below 5% less than estimated cost put to tender, No APS
 - ii) From 5% and above and below 10% less than the estimated cost put to tender, 50% of difference between estimate cost put to tender and bid amount)
 - iii) From 10% and above less than the estimated cost put to tender, 150% of difference between estimate cost put to tender and bid amount).
5. The bidders should complete the work within the stipulated days as per the work programme mentioned in the DTCN.
 6. The undersigned reserves right to increase or decrease the quantity of materials accept or reject any or all the Tenders without assigning any reason thereof.
