Applications are invited for engagement of **One Animal Biologist (Wildlife)** with a monthly fixed remuneration of Rs. 50,000/- at Deogarh Forest Division, Deogarh, Odisha. Desirable Experience: Prior experience in wildlife management, sampling design, and animal abundance estimation preferred. Ability to work in harsh field conditions. Knowledge of data management in MS-EXCEL, GIS and Remote Sensing is desirable. Research or peer reviewed publications in wildlife.

Age Limit: Upper age limit is 35 years as on 31/10/2025, including relaxable up to 5 years in case of SC/ST/SEBC candidates.


Other Conditions:
