The Block Development Officer, Talcher on behalf of the Governor of Orissa invites Percentage rate Procurement bid in double cover system for the goods as detailed in the table, from the class of eligible suppliers have being manufacturing units or importers/ authorized distributors on behalf of manufactures of the quoted Brand or Model registered with the State Government and contractors of equivalent grade / Class registered with Central Government/ MES / Railway, to be eventually drawn up in Judicial Contract (Affidavit Format) form, for supply of goods to the undersigned.

Interested bidders may obtain further information at the same address. The bid documents will be exclusively available in the District Web Portal www.angul.odisha.gov.in (No sale at Office). The paper cost of @Rs.10000/- per each medical equipment mentioned in Col-2 is to be submitted separately along with the Bid Documents drawn in favour of Block Development Officer, Talcher in the shape of Demand Draft from any scheduled commercial Bank.

3. Bids must be accompanied with E.M.D. (Bid Security) of the amount specified for the work in the table at Col.4 above in shape of N.S.C./K.V.P./P.O.T.D / Post Office Savings Pass Book / Term deposit/Bank Draft receipt of any Scheduled Commercial Bank (Valid minimum one year from the date of receipt) duly pledged in favour of Block Development Officer, Talcher. Bids without E.M.D. or in other shape will not be considered and liable for rejection.

N.B:- E.M.D. in shape of Cash / Pay Orders or Bankers Cheques is not acceptable.

4 The sale of the bid document shall start from dt. 22.10.2025 in the District Web Portal www.angul.odisha.gov.in (No sale at Office). The cost of bid document as mentioned in col. No-5 has to be paid by each bidder in shape of demand draft only drawn in favour of Block Development Officer, Talcher from any Scheduled Commercial bank. Sale of bid document will be closed at 3 .30 P.M on dt. 12.11.2025. Bid document will be received from dated 22.10.2025 to dated 12.11.2025 during office hours in the office of Block Development Officer, Talcher.


5. Bids must be delivered through Speed Post/ Registered Post (India Post) /Courier Services having identification No. **TALC- 04 / 2025-26** and identified with the name of work put to tender. The undersigned is not responsible for postal delay if any, in the delivery of the documents for non- receipt of the same.

6. Bidders shall submit original affidavit regarding authenticity of their documents and 1 % (One Percent) E.M.D. along with their bids. Bids shall be accompanied with self attested true copy of valid registration certificate, GSTIN and PAN card, ITR, otherwise his/her bids shall be declared as non-responsive and thus liable for rejection. The original certificates of the lowest bidder are to be produced before Block Development Officer, Talcher for verification.


7. Bidders can submit one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection.

8. The bid will be opened at 11. 00 A.M. on dt. 14.11.2025 in the office of the Dean & Principal, PMP MCH, Talcher, in the presence of the bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the last date of sale and receipt / opening of the bids as specified, the bid will be sold and received / opened on the next working day at the same time and venue.
9. If the rate quoted by a bidder is less than 15% of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system, where all bidders/ their authorized representatives, the tender inviting authority/ his authorized representative and Accounts Officer of Block and PMP Medical College will remains present.
10. That the selected Bidder should have provide 3years of onsite Comprehensive Warranty and Within 15 days of Technical Bid Opening, the bidder must physically demonstrate all quoted products. No digital media (such as video, presentation, or online demo) will be entertained.
11. For Security Deposit @ 1% (One Percentage) of the supply cost shall be deducted from bills.
12. Other details can be seen in the bidding documents (DTCN).
13. The undersigned reserves the right to cancel/reject in partly/fully or all tenders without assigning any reasons thereof.


