**INVITATION FOR BIDS (IFB)**

1. The Block Development Officer, Banarpal on behalf of Government of Odisha invites off line sealed tender in **single cover system** through e-procurement for the works detailed in the table below from the eligible class of contractors registered with State Governments & contractors of equivalent grade / class registered with Central Government / MES / Railways for execution of Civil works. The proof of registration from the appropriate authority shall be enclosed along with the bid. The registered bidders outside of Odisha State can participate in this off-line tender process after necessary portal enrolment but shall have to subsequently undergo registration with appropriate authority of the Odisha State Govt. within a month of acceptance of bid. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms and conditions of contract and other necessary documents.

2. The Bidder shall to deposit required **E.M.D. / Bid Security** amount specified for the works in the table Col- 05 above as part of its bid through process as mentioned in the DTCN vide Office Memorandum No. 17254/W/dated 05.12.2017 of Works Department, Govt. of Odisha.
3. The Bidder shall to deposit the **cost of Bid document** (Non-refundable) amount specified for the works in the table Col-06 above per set towards cost of the bid through process as mentioned in the DTCN vide Office Memorandum No. 17254/W/dated 05.12.2017 of Works Department, Govt. of Odisha. Those who want to download from website and send the Tender paper to Block Development Officer Banarpal must draw Demand Draft in favour of Block Development officer Banarpal, payable at Banarpal.
4. Additional Performance Security should be furnished by the successful bidder when the bid



amount is less than the estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost, i.e., estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of N.S.C. / K.V.P. / Term Deposit Receipt pledged in favour of BDO, Banarpal **within seven days from the date of declaration as successful bidder**, otherwise the bid of the successful bidder shall be cancelled and the security deposited shall be forfeited. Further, proceeding for black listing shall be initiated against bidder as per **Works Department Office Memorandum No. 14299 dated. 03.10.2017.**

6. The Bid documents will be available in the Block Office for off line bidding.
7. The bidder must possess compatible Digital Signature Certificate (DSC) of Class-II or Class-III.
8. Period of availability of tender Off-line/ Date and time of bidding off-line/ Last date of seeking clarification/ Date of opening of tender etc. Details as follows –

9. The bid for the work shall remain valid for a period of 90 days from the last date of receipt of bid. If any bidder / tenderer withdraws his bid / tender before the said period or makes any modification in the terms and conditions of the bid, the EMD deposited at the time of submission of tender shall stand forfeited.
10. No Engineer of Gazetted rank or other Gazetted officer employed in Engineering or Administrative duties in an Engineering Department of the State Government is allowed to work as a contractor within a period of two years after his retirement from Government service without Government permission.
11. The Bidders should ensure clarity/ legibility of the documents uploaded by them to the portal. Non-submission of legible documents may render the bid non-responsive.
12. **If the rate quoted by the bidder is less than 15% of tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids.** But if more than one bid is quoted at 14.99% (Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will **finalize the tender through a transparent lottery system to be drawn on 06.01.2026 at 11-00AM in presence of all bidders/ their authorized representatives.** In the event of the specified date for drawal of lottery being declared a holiday for the officer inviting Bid, lottery will be drawn at the appointed time on the next working day.
13. Other details can be seen in the bidding documents, which is available in the Block Office, Banarpal.



14. The following Documents should be furnished with the tender paper failing which the tender is liable to Rejection.
- A) EMD Pledged in favour of BDO Banarpal
  - B) Attested copy of valid Contractor Registration Certificate.
  - C) Attested copy of valid Pan Card & GST filling reports.
  - D) SC/ST Contractors submit original Affidavit in support of cast certificate and attested copy of Cast certificate.
  - E) Bank Draft towards cost of Tender paper in favor of BDO Banarpal.
15. The originals of all the scanned documents of the successful lowest bidder will be scrutinized **within 5 (five) days** of opening of the tender in the office of the Block Development Officer. In the eventually of failure on the part of the lowest successful bidder to produce the original documents, he will be debarred in future from participating in tender for 3 years and will be black listed by the competent authority. In such a situation, successful L-2 bidder will be required to produce his original documents for consideration of his tender at the negotiated rate equal to L-1 bidder.
16. The authority will not be held responsible for any technical snag or communication failure during bidding.
17. As Goods and Service Tax has come into force with effect from 01.07.2017, GST as applicable will be paid extra after gross bill amount prepared vide Section-15 and Section-142 (11-C) of Odisha Goods and Service Tax Act 2017.
18. If the Office happens to be closed on the date of opening of the technical bids as specified the bids will be opened on the next working day at the same time and venue
19. The authority reserves the right to cancel any or all the bids without assigning any reasons thereof.


