## TERMS AND CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing 2 Nos. of Semi-Skilled and Six Nos. (06) of Unskilled labourer on hire on daily basis

1. The service provider shall have all necessary valid documents such as valid Registration Certificate, Insurance Certificate, Labourer Registration Certificate, proof of up-to-date tax payment Xerox copies of Adhar Cards of Labourers. The department/ Office hiring the Labourers shall not be responsible for any loss of life / injury made to any person The service provider shall be responsible for such litigation.
2. The service provider should follow Labour Laws related to minimum wage act, Payment of wages act, Employees provident fund (EPF) and ESI if any applicable and workmen's compensation act
3. The hire charges to be paid on daily basis is final as per existing Government norms.
4. It shall be the responsibility of the service provider to provide Safety equipment's to workers such as gloves, boots, helmets etc.
5. In case of any health issues/personal reasons whatsoever the replacement of a Labourers of the same category shall be provided by the service provider.
6. In case of the any worker does not report regularly, the authority will be at liberty to reject the agreement without prior notice.
7. The worker shall report for duty for minimum of 26 days in a month and 08 hours working periods /day
8. In case of emergency, service provider will have to supply workers for duty as per the requirement including on holiday.
9. Daily hire charges of each worker will be paid in every succeeding month, as per possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
10. The age of the worker shall not be more than 18 years old.
11. If the services are found to be unsatisfactory the client shall give one month notice and terminate the agreement.
12. In case the service provider intends to withdraw the services of worker terminate the agreement, it shall be mandatory upon him to grant one month notice such withdraw of service and termination of agreement.
13. If the bidder violates any of the terms of contact, Government shall forfeit the entire of security deposit.


