1. The Block Development Officer, Angul on behalf of the Governor of Orissa invites **Percentage rate civil bid** in single cover system for the works as detailed in the table, from the class of eligible contractors as mentioned in Col.4 (four) , registered with the State Government and contractors of equivalent grade / Class registered with Central Government/ MES / Railway, to be eventually drawn up in PWD P-I form, for execution of Building (Civil Work). The proof of registration from the appropriate authority shall be enclosed along with the bid. If successful, the bidder who has not registered under State Government has to register under the State PWD in appropriate class of eligibility before signing the agreement. Bidders may submit bids for any or all the following works.

2. Bid documents consisting of plans, specifications, the schedule of quantities and the set of terms & conditions of contract and other necessary documents can be seen in the office of the Panchayat Samiti, Angul during office hours every day except on Sunday & Public holidays till last date of sale and receipt of tender paper. Interested bidders may obtain further information at the same address.

3. Bids must be accompanied with E.M.D. (Bid Security) of the amount specified for the work in the table at Col.5 above in shape of N.S.C./K.V.P./P.O.T.D / Post Office Savings Pass Book / Deposit receipt of any Scheduled Bank (Valid minimum one year from the date of receipt) duly pledged in favour of Block Development Officer, Angul. Bids without E.M.D. or in other shape will not be considered and liable for rejection.

N.B:- E.M.D. in shape of Cash / Pay Orders or Bankers Cheques / Bank Draft is not acceptable.

4. The bid document will be available in District Web Portal (www.angul.odisha.gov.in) from dt.08.04.2026 to 17.04.2026 up to 5.30 PM. The bidders shall download the detail tender call notice from the District Web Portal only during the aforesaid period. The cost of bid document as mentioned in col. No.6 has to be paid by each bidder in shape of demand draft only drawn in favour of Block Development Officer, Angul from any scheduled nationalized bank payable at Angul. Bid document will be received from dated. 08.04.2026 to dated 18.04.2026 during office hour in the Office of the Block Development Officer, Angul through Registered Post/ Speed Post only. No other mode of submission is acceptable.

5. Bids must be delivered through Speed Post/ Registered Post having identification No.AGLB- 05/ 2025-26 and identified with the name of work put to tender. The undersigned is not responsible for postal delay if any, in the delivery of the documents for non- receipt of the same.

6. Bidders shall submit an original affidavit regarding the authenticity of their documents along with 1% (One Percent) Earnest Money Deposit (E.M.D.) with their bids. The bids must be accompanied by self-attested true copies of a valid Registration Certificate, GSTIN, and PAN Card, failing which the bid shall be declared non-responsive and liable for rejection. The original certificates of the lowest bidder shall be produced before the Block Development Officer, Angul for verification

7. Bidders can submit one tender paper for a particular work. Submission of more than one tender paper by a bidder for a particular work will be liable for rejection.

8. Engineering Contractor desirous to avail the facility of exemption of E.M.D. is required to submit affidavit to the effect that he/she has not yet availed the facility for more than two works during the current financial year, failing which his/her tender will be rejected.

9. The bid will be opened at 11. 00 A.M. on dt. 21.04.2026 in the office of the undersigned, in the presence of the bidders or their authorized representatives, who wish to attend. If the office happens to be closed on the last date of sale and receipt / opening of the bids as specified, the bid will be sold and received / opened on the next working day at the same time and venue.


10. If more than one bidder quotes the same rate (considering decimal up to two places for all practical purposes), the Tender Accepting Authority shall finalize the tender through a transparent lottery system. The lottery shall be conducted in the presence of all concerned bidders or their authorized representatives, the Tender Inviting Authority or his authorized representative, and the Accounts Officer of the Block.

11. Additional Performance Security shall be obtained from the bidder when the bid amount is less than the estimated cost put to tender. In such event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish as Additional Performance Security as per Govt. of Odisha, Works Department Office Memorandum No.173 Dt.03.01.2026 in shape of Demand Draft/Term deposit Receipt pledged in favour of Block Development Officer, Angul within 7(seven) days otherwise the bid shall be cancelled and the security deposit be forfeited. Further proceeding for blacklisting shall be initiated against the bidder.

12. For building and other Construction Workers Welfare Cess @ 1% (One Percentage) of the cost of construction shall be deducted from bills.

13. Other details can be seen in the bidding documents.

14. The undersigned reserves the right to cancel/reject the tenders in partly or fully without assigning any reasons thereof.




