Applications are invited from the desirous candidates having requisite qualification and experience along with supporting documents as required under Rules-5 and 6 of the Family Courts (Orissa) Rules, 1990 for appointment to the vacant post of counselor (one post) in the Court of the Judge, Family Court, Angul. The Counsellor shall be appointed by the Hon'ble High Court of Orissa, Cuttack.

1. ELIGIBILITY AND QUALIFICATIONS OF COUNSELLOR:

A candidate, in order to be eligible for the above post;

(a) Shall be a citizen of India.

(b) Shall have a Master's Degree in Social Science preferably in Sociology or Psychology.

Provided that, where such persons are not available, persons above the age of thirty five working in the field of social service and welfare activities and engaged in promoting the welfare of Family and Child Care with a degree in Social Science preferably in Sociology or Psychology shall be eligible.

(c) Shall have minimum experience of three years in family counseling.

(d) Shall be able to speak, read and write Odia and have passed test in Odia equivalent to the M.E. Standard.

(e) Shall be of sound health, good physique and free from organic defects or bodily infirmity, and

(f) Shall have not more than one spouse living.

2. FUNCTIONS OF A COUNSELLOR:

Counsellor entrusted with any petition shall assist and advise the parties regarding the settlement of subject-matter of dispute between the parties or any part thereof. The counselor shall also help the parties in arriving at a reconciliation.

3. FEE OF A COUNSELLOR:

Fee of the counselor is Rs.6000/- per month. Further, the assisting fee per day of actual work of the Counsellor is Rs.1000/- pursuant to Resolution No.IJ-02/2019-6839/L dated 23.04.2025 of the Government of Orissa, Law Department.
