TENDER CALL NOTICE No. 01/ KISHORENAGAR/2026-27

1. The Block Development Officer, Kishorenagar on behalf of Governor of Odisha invites percentage rate bids in sealed cover in conformity with detailed tender call Notice No 01/2026-27 to be eventually drawn up in state P.W.D. Form P-1 contract for the execution of work detailed in the table below from the intending and eligible Class of Contractors mentioned against the work registered with the State Government and contractor of equivalent Grade/Class registered with Central Government/M.E.S./Railways for execution of Civil works on production of definite proof from the appropriate authority.

- Bids shall be received by the Block Development Officer, Kishorenagar in official time from **Dt. 08-04-2026 and close on Dt 21-04-2026 at 1 PM (only on official days and official hours)** through registered/speed post only on the address "To the Block

Development Officer, Kishorenagar". The authority will not be held responsible for postal delay in the delivering of the documents or non-receipt of the same.

4. **The tender will be opened in the Conference Hall of the Block Development Officer, Kishorenagar at 9 AM**, on 23-04-2026 in presence of the bidders or their authorized representatives who wish to attend. If the office happened to be closed on the date of receipt /opening of the bids as specified, the bids will be received /opened on the next working day at the same time and venue.
5. If the tender documents sent through registered /Speed Post does not reach the concerned office by the above date and time, the offer will not be considered on any account even if the tender documents were dispatched by the tenderer before the due date.
- 6 The following documents should be furnished along with the tender paper failing which the tender is liable for rejection.
 - a. Original Demand Draft of Rs.6000/- in favour of Block Development Officer, Kishorenagar payable at Kishorenagar towards Cost of tender paper (non-refundable)
 - b. EMD duly pledged in favour of the BDO, Kishorenagar.
 - c. Self-Attested copy of the contractor valid registration certificate/ License.
 - d. Self-Attested copy of PAN CARD.
 - e. Self-Attested copy of valid GST registration Certificate.
 - f. Attested copy of caste certificate for SC/ST contractor desirous of availing preference, if applicable
 - g. Self-Attested Copy of PH Certificate for differently-abled Contractors, if Applicable
 - h. Affidavit for Engineer contractor, if any
 - i. Signed copy of DTCN and price bid duly filled in and signed by the tenderer.
 - j. An affidavit regarding authenticity of the credentials.
 - k. No Relationship Certificate in the prescribed Performa.
7. The tender is to be submitted in one cover along with all document described and documents required as per the relevant clauses of this DTCN and special conditions if any. **The cover is to be sealed and super scribed as the name of the work for bid as mentioned in column No.2 of Box 01 of the tender call notice failing which it will be liable for rejection.**
8. The bid must be accompanied by EMD of the amount @ 1%(One percent) of the tender cost as mentioned in column No.5 along with tender in the form of DD duly pledged in favor of the Block Development Officer, Kishorenagar as per the terms and conditions laid down in OGFR and in no other form. Tenders not accompanied with EMD as specified above shall be liable for rejection.
9. S.C. /S.T. Tenderers can avail facilities as per Govt. circular.
10. The bidders shall have to furnish an affidavit along with the bid regarding the authenticity of the bid document
11. **AMENDMENT TO NEGATIVE BID CAPS & APS: WORKS DEPT. [173/03.01.2026]**

After careful observation, Government has been pleased to abolish the extant provisions of threshold negative bid caps (14.99%) introduced in Appendix-IX, Clause 36 of OPWD Code Volume-II in the procurement of works undertaken by the Govt of Odisha and its agencies to ensure the

procurement process results in a viable and successful manner with adoption of following incremental Additional Performance Security (APS) system:

Additional performance security shall be taken on an incremental basis from the selected bidder for low bid prices in the project works as under:

11.1 where the bid price is below 0% but not below 10% of the project cost put to bid, no additional performance guarantee/security percentage is required.

11.2 where the bid price is below 10% but not below 20% of the project cost put to bid, the additional performance guarantee/security percentage shall be incremented by 0.1% for every percentage of bid price below 10% of the project cost put to bid starting at 11% with the additional bid performance guarantee being 0.1% and this additional performance guarantee percentage shall be applied on the bid price.

11.3 where the bid price is 20% or more below of the project cost put to bid, the additional performance guarantee percentage shall be incremented by 0.2% for every percentage of bid price below 20% of the project cost put to bid in addition to 1% of the bid price and this additional performance guarantee percentage shall be applied on the bid price;

11.4 The additional performance guarantee percentage shall be rounded off to the next lower percentage based on whether the decimal point of the percentage of bid price is below 0.5% or next higher percentage based on whether the decimal point of the percentage of bid price is 0.5% or more.

11.5 The additional performance security shall be treated as part of the performance security.

11.6 Justification for abnormally low bids shall be scrutinized by the Departmental Technical Committee and recommended to the competent authority of the Administrative Department for the approval of the Additional Performance Security (APS). An abnormally low bid is one in which the Bid price, in combination with other elements of the Bid, appears so low that it raises material concerns as to the capability of the Bidder to perform the contract at the offered price. Procuring Entity may, in such cases, seek written clarifications from the Bidder, including detailed price analyses of its Bid price in relation to scope, schedule, resource mobilization, allocation of risks and responsibilities, and any other requirements of the bid document. If, after evaluating the price analyses, the procuring entity determines that the Bidder has substantially failed to demonstrate its capability to deliver the contract at the offered price, the Procuring Entity may reject the Bid/ Proposal. However, it would not be advisable to fix a normative percentage below the estimated cost, which would automatically be considered as an abnormally low bid.

12. All bids received will remain valid for period of 30 days from the last date of receipt of bids and the validity of the bids can also be extended, if agreed to by the bidders with the department.

13. Other details can be seen in the bidding documents.

14. If the L1 bidder does not turn up for agreement after finalization of tender, then he/she shall be debarred from participation in bidding for three years and action will be taken to blacklist the bidder. In that case L2 bidder if full fill, other required criteria would be called for drawing agreement for execution of work subject to the condition, that L2 bidder negotiate at par with the rate quoted by the L1 bidder otherwise tender will be cancelled.

15. The rates to be quoted by the contractor shall be excluding GST. The implementation of the GST rules by the GOVT of Odisha is to be accepted by the bidder at any point of time.

16. If the rate quoted by the tenderers is found to be same, tender committee will decide the tender.

17. The Block Development Officer, Kishorenagar reserves the right to reject any or all the tenders without assigning any reason thereof.
