As you are aware, “Bikashita Gaon Bikashita Odisha” (BGBO) scheme has been rolled out aiming at bridging critical infrastructure gaps and fostering inclusive growth across rural Odisha . While the initial framework was established via Resolution No. 2291 dt.28.01.2025 , the guidelines have since been refined vide necessary amendments to accommodate various requirements.

In alignment with the latest amendments approved vide Resolution No. 799 dated 07.01.2026, the Department seeks to further encourage active civic participation, streamline the project selection process and prioritize the creation of sustainable community assets .

To ensure a comprehensive understanding of the revised procedural workflow, Comprehensive Guideline (Annexure-A) is hereby enclosed for immediate implementation .

Further, all projects initiated under the BGBO scheme must be processed and approved exclusively through the BGBO web portal . After approval, the execution and real-time monitoring of projects, the established Panchayati Raj Project Management System (PPMS) protocol shall be strictly followed .

Technical Assistance: A dedicated Help Desk (Contact No: 0674-2392906, 7077262348, 9938706593) has been established to provide clarifications regarding PPMS and BGBO administrative procedures .

You are therefore, requested to instruct all field functionaries for strict adherence to the operational guideline to ensure the smooth and timely execution of projects.

COMPREHENSIVE GUIDELINE**

“Bikashita Gaon Bikashita Odisha” (ବିକଶିତ ଗାଁ ବିକଶିତ ଓଡ଼ିଶା)

1. Background:

Rural infrastructure development is vital for enhancing the quality of life in Rural Odisha and fostering economic growth. In order to boost the rural infrastructure for the holistic development of the State, the State Government has been pleased to launch a transformative umbrella Scheme called “Bikashita Gaon Bikashita Odisha” (ବିକଶିତ ଗାଁ ବିକଶିତ ଓଡ଼ିଶା). The Scheme aims at bridging the critical gaps leading to accelerated and inclusive growth of rural Odisha by taking up various sustainable developmental projects. This will substantially lead to development of varied forms of infrastructure and will act as a gateway to fulfil the objectives of Bikashita Odisha.

2. Objectives:

“Bikashita Gaon, Bikashita Odisha” highlights the significance of rural areas in Odisha's economic, social and cultural growth. It recognizes that villages are the backbone of Odisha's economy, with a majority of the population engaged in agriculture and allied activities. Development of Rural Connectivity is critical for economic development and social integration of a State. Therefore, provision of road connectivity to unconnected villages/ habitations to bridge the connectivity gap and development of both inter and intra village roads will be of prime importance under this Scheme. The Scheme also envisages to take up need based community projects for creating durable assets for community.

3. Key Features: -

3.1 Construction of roads, bridges, culverts etc. in rural Odisha (both inter and intra village roads) shall be taken up under the Scheme. Unconnected villages/habitations in PVTGs, Naxal dominated, remote hilly areas shall be connected through intra and inter village roads.

- 3.1.1 The road infrastructure in rural areas which requires improvement shall be included in the project list basing on factors like population density, economic activity and geographical challenges.
 - 3.1.2 Construction of road up to formation level (wherever required) can be taken up in convergence with MGNREGS subject to availability of suitable soil within head lead.
 - 3.1.3 The road projects such as black top road, cement concrete road and paver block roads shall be taken up.
 - 3.1.4 The habitations and villages situated within the reserve forest/forest area having road formation will be improved up to metalling standard.
 - 3.1.5 Funds to be utilized for road projects shall not exceed Thirty-Five percentage (35%) of total allotted funds.
 - 3.1.6 Based on the requirements, standalone cross drainage works with necessary approach road will also be taken up.
 - 3.1.7 The funds will be allocated in such a manner that the road will be completed in all respects within the allotment.
 - 3.1.8 A comprehensive technical guideline will be issued to define the specifications and quality standards for the roads/bridges/culverts to be constructed.
- 3.2 Construction of civic assets and amenities in villages.
- 3.2.1 Construction of civic assets like kalyan mandap, community center, bathing ghat, changing room near ponds/river banks, market sheds, construction of drains etc. will be taken up wherever required.
 - 3.2.2 Construction of Bhoga Mandap, Bhagabata Tungi, Cultural Centres etc. will be taken up to provide basic amenities and services for devotees/pilgrims in the place of worship of all religions. Toilets and water supply facilities near such projects may be developed out of Swachh Bharat Mission (SBM) and Jal Jeevan Mission (JJM) wherever required.
 - 3.2.3 Construction and rejuvenation of community pond and water harvesting structure will be taken up.
- 3.3 Improvement of infrastructure for education.

- 3.3.1 Construction of additional classrooms, modernization and expansion works of the existing infrastructure.
- 3.3.2 Construction of reading rooms (with cubicles, each cubicle having a small table and chair), with electricity and internet facility and also washroom provision should be taken up in Block Headquarters and other thickly inhabited area. These reading rooms should remain open from 9 am to 9 pm. Students of schools and colleges and pass out students preparing for job examinations should be allowed to read in these reading rooms on payment of nominal charges.
- 3.4 Development/Construction of sports infrastructure i.e. small outdoor playful and enjoyable physical activity facilities such as Long Jump & High Jump Pit, Rope Climbing, Horizontal Bar for Monkey-Hanging and such low-cost innovative facilities shall be developed.
- 3.5 Improvement of need based micro tourism spots can also be taken up under this Scheme.
- 3.6 Maximum upto 5% of the total sanctioned amount can be utilized for new innovative projects for community use.
- 3.7 Projects of similar nature taken up by PR & DW Department and other Departments can be dovetailed/converged under the Scheme.
- 3.8 Projects with estimates less than Rupees 3 Lakh shall not be taken up.
- 3.9 Projects taken up under erstwhile Ama Odisha Nabin Odisha (AONO) can be completed under the new scheme provided minimum 20% (Twenty Percentage) expenditure has been incurred.

4. Admissibility:

Eligible projects must meet the following criteria:

- 4.1 The project should be of developmental nature.
- 4.2 Recurring expenditure of the projects is not admissible.

5. Financial Allocation:

Funds will be allocated strategically, for priority projects and with provisions for underdeveloped and marginalized areas to ensure equitable development.

5.1 Funds will be allocated to Zilla Parishads and subsequently Zilla Parishad will allocate the funds to Blocks/ GPs on the basis of the population of the Block and GP respectively.

5.2 Forty Percent (40%) of the allocation shall be earmarked for ITDA Blocks.

5.3 It should be ensured that, the projects taken up shall be completed in all respect within the allotment.

6. Source of Funds:

6.1 The expenditure under this State specific Scheme will be met out of State budget.

6.2 PR & DW Department will make necessary budget provision under this Scheme.

7. Selection of Projects:

A participatory process, involving Gram Sabhas, will ensure that projects address real community needs.

7.1 A need based project list as per the financial allotment for concerned financial year shall be prepared by the Gram Sabha. The Nodal officer of the block attending the Gram Sabha shall forward the project list immediately to the Collector.

7.2 Every year, the Collector shall seek proposals also from PRI members, elected representatives and civil society members by publishing a notice in the notice board of the Collectorate, Zilla Parishad, Block, GPs and in the District web portal. All such projects addressed to the Collector shall be submitted within 07 days of publication of notice.

8. Approving Authority:

8.1 There will be a District Level Committee under the chairmanship of the Collector-cum- Chief Executive Officer. Chief Development Officer-cum- Executive Officer, Zilla Parishad of the concerned District will act as Member-Convener with Additional District Magistrate (General), SE/EE

of the Rural Development Department and APD, Technical Zilla Parishad as the members.

8.2 The District Level Committee; after receipt of the project list from the Gram Sabha and considering all the proposals received as per Para 7.2 will scrutinize the admissibility and feasibility of the projects and finalize the projects as per local need & priority keeping in view of the financial allocation for the financial year.

8.3 List of the finalized projects will be approved by the Collector of the concerned District.

8.4 Administrative approval and Technical sanction shall be accorded as per Panchayat Samiti Accounting Procedure Rules, 2002 and subsequent amendments made therein from time to time.

9. Sanction and Release of Funds :

9.1 Funds will be released from PR & DW Department to the PL Accounts of the CDO-cum-EO, Zilla Parishad out of which, the CDO-cum-EO, Zilla Parishad shall draw the funds in Grants-in-Aid bill.

9.2 Expenditure towards IEC and programme management activities like convening meetings, Social Audit, Inspection of site, Photograph of projects in different stages, IEC campaigns, data entry, mobility support, MIS, development of web portal, establishment of PMU, procurement of Computer, Printer with scanner and Photo Copiers etc. shall be met out of IEC budget head of Department following due financial procedure.

9.3 Government shall have the power to relax the financial allocation in exceptional cases.

10. Execution of Projects :

10.1 Selection of Executing Agency:

10.1.1 The Panchayat Samiti shall execute the work as per Panchayat Samiti Accounting Procedure Rules, 2002 and subsequent amendment made therein from time to time.

10.1.2 The Collectors will select appropriate agencies for execution of the projects. After completion of the projects, the Collectors shall ensure proper maintenance of the assets.

10.1.3 No pro-rata charges are applicable in case of Departmental execution of work.

10.2 Provision of OPWD Code shall be followed for execution of Projects.

10.3 For technical assistance, design and specifications of projects undertaken, the guideline of the concerned Departments will be followed.

11. Monitoring and Supervision:

11.1 Measures for regular monitoring and supervision to ensure proper implementation of the Scheme shall be taken at the State and District levels.

11.2 The Collector of the District shall be in overall charge of supervision and monitoring of the progress of work in the District.

11.3 The CDO-cum-EO, Zilla Parishad shall render requisite support and assistance in review and monitoring.

11.4 Regular review shall be taken by the Collector on utilization of funds and progress of work.

11.5 Social Audit shall be conducted for proper monitoring and supervision of each project.

11.A- Defect Liability:

For all projects with an estimated cost exceeding Rs.10.00 lakh, a Defect Liability Period (DLP) of 03 (three) years shall be applicable from the date of completion and handing over the projects. During this period, the executants shall be solely responsible for the proper upkeep and maintenance of the works at his own cost, ensuring that any defects, damages, or deficiencies arising from workmanship, materials or design are promptly rectified, without imposition of any additional financial implication to the client or authority.

12. Accountability:

The durable assets which are created under this Scheme are primarily community based projects. Hence, the community must actively monitor the quality of work and take responsibility for the upkeep and maintenance of these assets.

13. Utilisation of Fund:

The CDO-cum-EO, Zilla Parishad shall submit UC to the Government in PR & DW Department in every quarter duly countersigned by the Collector and furnish monthly MIS report about progress of each work.

14. Transparency:

14.1 A web based MIS and mobile app shall be developed for real-time monitoring of the projects.

14.2 In order to maintain transparency in execution of projects, different stages of project construction i.e., Before start, Ongoing and Completion, shall be geotagged through mobile app and will be uploaded in the web portal to be developed.

14.3 The Government in Panchayati Raj & Drinking Water Department shall have the authority to issue any clarification needed and also to modify/change the guideline as and when required. The Guideline will come into force with immediate effect.

RESOLUTION

Subject: Modification to the Guidelines for "Bikashita Gaon Bikashita Odisha" Scheme.

To promote active citizens participation, simplify project selection and to ensure construction of long-term assets for community, the resolution to operational guidelines of the "Bikashita Gaon Bikashita Odisha" scheme issued vide No. 2291/PR&DW, dated 28.01.2025 is hereby modified as follows:

(A) Substitution of Para 7 (Selection of Projects) with the following.

A participatory process, involving Gram Sabhas, will ensure that projects address real community needs.

- 7.1- A need based project list as per the financial allotment for concerned financial year shall be prepared by the Gram Sabha. The Nodal officer of the block attending the Gram Sabha shall forward the project list immediately to the Collector.
- 7.2- Every year, the Collector shall seek proposals also from PRI members, elected representatives and civil society members by publishing a notice in the notice board of the Collectorate, Zilla Parishad, Block, GPs and in the District web portal. All such projects addressed to the Collector shall be submitted within 07 days of publication of notice.

(B) Substitution of Para 8 (Approving Authority) with the following.

- 8.1- There will be a District Level Committee under the chairmanship of the Collector-cum- Chief Executive Officer. Chief Development Officer-cum-Executive Officer, Zilla Parishad of the concerned District will act as Member-Convener with Additional District Magistrate (General), SE/EE of the Rural Development Department and APD, Technical Zilla Parishad as the members.

- 8.2- The District Level Committee; after receipt of the project list from the Gram Sabha and considering all the proposals received as per Para 7.2 will scrutinize the admissibility and feasibility of the projects and finalize the projects as per local need & priority keeping in view of the financial allocation for the financial year.
- 8.3- List of the finalized projects will be approved by the Collector of the concerned District.
- 8.4- Administrative approval and Technical sanction shall be accorded as per Panchayat Samiti Accounting Procedure Rules, 2002 and subsequent amendments made therein from time to time.

(C) Insertion of a new Para 11-A (Defect Liabilities)

- 11.A- For all projects with an estimated cost exceeding Rs.10.00 lakh, a Defect Liability Period (DLP) of 03 (three) years shall be applicable from the date of completion and handing over the projects. During this period, the executants shall be solely responsible for the proper upkeep and maintenance of the works at his own cost, ensuring that any defects, damages, or deficiencies arising from workmanship, materials or design are promptly rectified, without imposition of any additional financial implication to the client or authority.

- (D) Resolution (Addendum) No. 6765 dated 11.03.2025 and Corrigendum No. 8142 dated 25.03.2025 thereto are hereby withdrawn.**

The above modifications to the "Bikashita Gaon Bikashita Odisha" Scheme guidelines shall come into effect from the date of publication of this resolution.


